FROM YOUR BOARD PRESIDENT

We had a good meeting in January and there were several first-time people



in attendance, which is always good to see. The meeting started with the announcement that Lynn Gilbert, our Vice-President, had submitted a letter of resignation. We thanked her for her service to us and sadly accepted the resignation. We were fortunate that another shareholder had recently expressed an interest in joining the Board of Directors – David Holt. I interviewed Dave and felt that he would make an excellent member of the board, so I suggested that the remainder of the Board members approve his appointment to fill the vacancy created by Lynn's resignation. They all agreed, so he was asked to join us at the front table and give us a brief biography.

Over the past few months, we've heard a lot of comments about the compliance committee not getting anything done. There seems to have been miscommunication and/or misunderstanding about what their duties and responsibilities in the community are. I reached out to our corporate attorney for clarification about those duties and responsibilities. Here's a brief recap, and as my boss always reminds me, I'm putting the last sentence first.

The PRIMARY responsibility of that committee is to conduct a hearing and confirm or reject any fines that the board has imposed on an owner for violation of the rules and regulations. It is NOT their responsibility to go around and find or report violations. Doing so would end up disqualifying them from ruling on the validity of a fine if and when it got to the point of an official hearing. Just like other provisions of our documents, an immediate family member or relative of the committee member should not report any violations.

So, you may ask, who is to report alleged violations? The short answer – YOU! Any shareholder has the duty to report violations of rules and regulations by other owners or tenants. You do so by submitting a written statement to our office identifying the property, the violator, and the alleged violation. If you have photos or videos of the violation you

should include that with your report. Once a report has been received our office manager or a member of the compliance committee will follow up with a visit to the property to confirm the violation. If a violation is confirmed it will trigger a series of up to three courtesy notices. These notices will provide a time frame of between 14 and 30 days to cure the violation. If, after the three letters have been sent, the situation has not been corrected a fourth letter will be sent with notice of a fine of \$100 per day up to a maximum of \$1,000. That notice will also specify a date for a hearing before the Compliance Committee where the homeowner can make their case for not addressing the violation. The management and/or board will also make their case for the approval of the fine. If the fine has reached the \$1,000 limit and is upheld the fine can become a lien against the property and recorded on the records of Manatee County.

Over the years our managers have sent numerous letters out to owners requesting that maintenance or repairs are needed and that if they remain unresolved a fine can be imposed. In the vast majority of instances the homeowner made the necessary fixes and the matter was settled without any difficulty. As a rule our owners WANT to do the right thing, they WANT their property to make a nice statement about themselves, and they take pride in their property. Up until recently Casa Loma did not have the mechanism set up to impose fines. Now we do! It is the sincere hope of our management, our board, and our compliance committee that everyone will do the right thing and get or keep their property in good condition.

This month's topic is Human Trafficking. What exactly is human trafficking? It involves the use of force, fraud, or coercion to obtain some type of labor or commercial sex act. Every year, millions of men, women, and children are trafficked worldwide – including right here in the United States. It can happen in any community and victims can be any age, race, gender, or nationality. Traffickers might use the following methods to lure victims into trafficking situations:

- Violence
- Manipulation
- · False promises of well-paying jobs
- Romantic relationships

Language barriers, fear of their traffickers, and/or fear of law enforcement frequently keep victims from seeking help, making human trafficking a hidden crime.

Traffickers look for people who are easy targets for a variety of reasons, including:

- · Psychological or emotional vulnerability
- Economic hardship
- Lack of a social safety net
- Natural disasters
- Political instability

The trauma caused by the traffickers can be so great that many may not identify themselves as victims or ask for help, even in highly public settings.

The safety of the public as well as the victim is important. Do not attempt to confront a suspected trafficker directly or alert a victim to any suspicions. It is up to law enforcement to investigate suspected cases of human trafficking.

Behind the sandy beaches and countless days of sunshine in Florida lies this dark crime that often goes unnoticed. According to the Human Tracking Hotline, Florid continues to rank third in the US behind California and Texas. In 2021, the state had 781 cases, which is 8.54% of the U.S. total.

To combat and crack down on human trafficking, Florida has local task forces in all its counties dedicated to human trafficking. The Florida Coalition Against Human Trafficking is an organization that works closely with victims of human trafficking,

providing them with food, shelter, medical treatment and other beneficial services to help these people restore their livelihoods. The Florida Alliance to End Human Trafficking is a nonprofit organization that was created by the Florida Legislature to lead the effort to end human trafficking in the state. Florida has some of the strongest laws against human trafficking in the country. Florida was also the first state to teach K-12 child trafficking prevention.

TRASH PICKUP GUIDELINES



We've seen residents placing large items of furniture, electronics, and appliances on the curb for pickup. Manatee County has a special procedure for such items as outlined below.

Furniture & Household Items:

- Two (2) large items may be placed at the curb with your regular garbage and picked up for free. Please do not exceed two (2) large per collection day.
- BBQ grills without propane tanks, bikes, prepared swing sets, prepared fencing, sinks, bathtubs, toilets, sleeper sofas, box springs and mattresses, mirrors or glass (taped, and six (6) feet or less in length).
- Only two (2) large items per pick-up.

White Goods / Appliances:

- White goods are large appliances such as refrigerators, air conditioners, washing machines, dryers, stoves, water heaters and freezers.
- There is a minimal charge for curbside disposal per appliance or item.
- You may also elect to dispose of your item at the landfill for a fee or utilize your one free annual pick up.
- To schedule pick up of white goods, please call the Utilities Customer Service at 941-792-8811.

Televisions:

Do NOT dispose of TVs in your trash. Prior arrangements must be made before placing a TV at the curb.

Disposal Options:

- Call 941-792-8811 and speak to a customer service representative for details to schedule a special pickup. You may use your one "free annual" option or pay a fee for this service.
- Deliver the TV to the Manatee County Landfill Monday through Saturday from 8:00 a.m. 5:00 p.m. and between 9:00 a.m. and 3:00 p.m. on the 3rd Saturday of each month for proper disposal at no charge.
- If you are able to unload your TV without assistance from County personnel, you may bring it to the Lena Road Landfill Monday-Saturday 8:00am-5:00pm. Please stop and speak with scalehouse staff; there will be no charge for disposal.
- Check with your local thrift store to see if they are accepting donations of working TVs.


