FOR YOUR GOOD HEALTH

 July is recognized as UV Safety Awareness Month and serves as a reminder that exposure to ultraviolet rays is the most important preventable risk factor for skin cancer.



- Exposure to ultraviolet rays is the most important preventable risk factor for skin cancer. UV rays come not only from the sun but from sunlamps and tanning beds. There are two types of UV rays that can reach and damage your skin: UVA and UVB.
- Here's how you can help reduce your risk of skin cancer:
- Minimize your exposure to the sun between 10 a.m. and 4 p.m., the hours when UV rays are strongest.
- Apply a generous amount of sunscreen before you go outside. Use a water-resistant, broadspectrum sunscreen with a sun protection factor, or SPF, of at least 30. Broad-spectrum means the sunscreen protects against both UVA and UVB rays. Apply it to all areas of your body that will be exposed to the sun.
- Reapply sunscreen every two hours, even on cloudy days. Reapply after swimming or sweating.

- Wear sunglasses with a UV coating (the label should say 100% UVA/UVB protection). This will reduce the amount of UV rays that reach the eye and protect your eyelids and the eye itself.
- Wear clothing that covers your body and shades your face. Wear a long-sleeved shirt, pants, and a wide-brimmed hat. Hats should provide shade for the face, ears, and back of the neck.
- Don't use sunlamps or tanning beds.

Protecting children from the sun

Skin damage from UV rays early in life can lead to skin cancer later in life. Keep children from too much sun exposure between 10 a.m. and 4 p.m., the hours when UV rays are strongest. Apply a generous amount of sunscreen often to children 6 months and older. Keep babies younger than 6 months out of direct sunlight. Dress your baby

in hats and lightweight clothing that covers most of the skin. The American Academy of Pediatrics approves using sunscreen on babies younger than 6 months if clothing and shade don't provide enough cover. Apply a small amount of sunscreen. Use it only on your baby's exposed areas such as the face and back of the hands.

Take care around sand

Sand and water reflect UV rays, even under a beach umbrella. If you're on the beach, cover up and use sunscreen.

INDEPENDENCE DAY CUSTOMS AND TRADITIONS

Independence Day is a national holiday marked by patriotic displays. It is also a federal holiday, so all non-essential federal institutions (such as the postal service and federal courts) are closed on that day. While the legal holiday remains on July 4, if that date happens to be on a Saturday or Sunday, then federal government employees will instead take the day off on the adjacent Friday or Monday, respectively.

Families often celebrate Independence Day by hosting or attending a picnic or barbecue; many take advantage of the day off and, in some years, a long weekend to gather with relatives or friends. Decorations (e.g., streamers, balloons, and clothing) are generally colored red, white, and blue, the colors of the American flag. Parades are often held in the morning, before family get-togethers, while fireworks displays occur in the evening after dark at such places as parks, sporting venues, fairgrounds, public shorelines, or town squares.

The night before the Fourth was once the focal point of celebrations, marked by raucous gatherings often incorporating bonfires as their centerpiece. In New England, towns competed to build towering pyramids, assembled from barrels and casks. They were lit at nightfall to usher in the celebration. The highest were in Salem, Massachusetts, with pyramids composed of as many as forty tiers of barrels. These made the tallest bonfires ever recorded. The custom flourished in the 19th and 20th centuries and is still practiced in some New England towns.

Independence Day fireworks are often accompanied by patriotic songs, such as "The Star-Spangled Banner" (the American national anthem); "Columbia, the Gem of the Ocean"; "God Bless America"; "America the Beautiful"; "My Country, 'Tis of Thee"; "This Land Is Your Land"; "Stars and Stripes Forever"; "Yankee Doodle"; "Dixie" in southern states; "Lift Every Voice and Sing".

Firework shows are held in many states, and many fireworks are sold for personal use or as an alternative to a public show. Safety concerns have led some states to ban fireworks or limit the sizes and types allowed. In addition, local and regional conditions may dictate whether the sale or use of fireworks in an area will be allowed; for example, the global supply chain crisis following the COVID-19 pandemic forced cancellations of shows. Some local or regional firework sales are limited or prohibited because of dry weather or other specific concerns. On these occasions the public may be prohibited from purchasing or discharging fireworks, but professional displays (such as those at sports events) may still take place.

A salute of one gun for each state in the United States, called a "salute to the union," is fired on Independence Day at noon by any capable military base.

New York City has the largest fireworks display in the country sponsored by Macy's, with more than 22 tons of pyrotechnics exploded in 2009. It generally holds displays in the East River. Other major displays are in Seattle on Lake Union; in San Diego over Mission Bay; in Boston on the Charles River; in Philadelphia over the Philadelphia Museum of Art; in San Francisco over the San Francisco Bay; and on the National Mall in Washington, D.C.

During the annual Windsor–Detroit International Freedom Festival, Detroit, Michigan hosts one of the largest fireworks displays in North America, over the Detroit River, to celebrate Independence Day in conjunction with Windsor, Ontario's celebration of Canada Day.

The first week of July is typically one of the busiest United States travel periods of the year, as many people use what is often a three-day holiday weekend for extended vacation trips.

TEN THINGS TO DO NOW BEFORE A HURRICANE

Here is a list of (10) things that you can do to prepare for the hurricane season right now. It is never too early to start getting ready.

- Make your family Disaster Plan. Make sure every family member understands the plan and identify meeting locations if you should become separated.
- 2. REMEMBER: All mobile home residents must evacuate, regardless of location.
- 3. Decide NOW where you would go if ordered to evacuate. If you must evacuate, do not delay; determine your route, leave early, and try to travel the shortest distance possible.
- 4. Check your Hurricane supply kit and be sure you have all the items you will need.
- 5. Make plans and purchase materials needed to protect your home before the storm.
- 6. Keep your home in good repair, trim trees, keep gutters clean and fix all roof leaks.
- 7. Purchase a battery-powered weather alert radio.
- 8. Inventory your property and possessions on paper and take a video survey of your property. Store these with insurance and other important papers in a safe place and send a copy to a relative out of the area. Put important papers and irreplaceable keepsakes in container to take with you.
- 9. Make sure your street address number is clearly marked on your home.
- 10. Whether you rent or own your home, review your insurance policies with your agent.

Supply Kit Suggestions

- 3 gallons of water per person per day keep at least 7-day supply
- 3-day supply of non-perishable food
- Manual can opener
- Portable, battery-operated weather radio
- Extra batteries
- Flashlights
- First aid kit
- Insect repellant & citronella candles
- · Fire extinguisher
- Cooler
- House keys and car keys
- Personal hygiene items toothpaste, toothbrush, deodorant, etc.

- Clothing at least one change per person
- Sanitation supplies toilet paper, garbage bags, disinfectant
- Blankets or sleeping bags
- · Basic tools and plastic tarp
- Portable cooker or small grill
- · Clean up supplies and trash bags
- Infant supplies diapers, wipes, formula, baby food, medications
- Minimum of 7-day supply of all prescription drugs, contact lenses, insulin, denture needs etc.
- Sturdy shoes or work boots
- List of emergency contacts, Personal address book (Dr. and family

Special Needs Evacuees

- Medications, list of medications, name and contact information for doctor(s).
- Any medical orders including "do not resuscitate" order, if applicable.
- Walker, wheel chair, and other medical equipment.
- Oxygen concentrator, if used.
- Call caregiver and family to inform them of your plans.
- Take care of all medical need such as dialysis when you hear a storm is approaching.

Pets

- Pets must arrive with a carrier or cage. Cages will not be available at evacuation site.
- Pets must remain in carrier except at scheduled exercise times.
- Owners must provide pet food, medications, and other pet supplies as needed, as well as food and water bowls.
- Owners must provide certification that pet(s) are current with rabies vaccination.
- Have proper ID collar and rabies license tag.
- Owners will not permit other shelter occupants to handle or approach pet(s).
- Owners are responsible for the care, feeding, and handling of their pet(s).
- · Newspaper/plastic bags for waste disposal.
- Toys and comfort items.
- Muzzles if necessary.
