

#### THAT CHURCH IN YOUR **NEIGHBORHOOD**

As a pastor, I have seen people's lives change literally - overnight. I'm one of them. Through the 80s, I was still a lost soul, without Christ and without God in this world. It was not until Easter Sunday of 1992 that I was able to truly turn my life over to God. A pastor had invited me to church several days earlier, and I felt compelled to attend a service every single day until I finally went that Sunday. I can honestly say that I went to bed that night a changed man. The morning after, I felt as if a great load had been taken off my shoulders. More importantly, I felt forgiven, and accepted. Ever since, Jesus has been my rock and my fortress, and my hiding place in time of need.

A year later, the Lord called me into the ministry, and I have been serving Him ever since. I have barely missed a Sunday service since that Easter celebration at that Hispanic Church in North Miami. Most of those services, I have been attending as a pastor. In 1995, we moved to Bradenton to start a Hispanic ministry at Bayshore Church of the Nazarene. Our first convert was a man from Nicaragua, who eventually moved back to this troubled country in Central America but has remained a believer all this time.

As many of you know, we hold worship services at the Club House here at Casa Loma every Sunday. At first, the services were conducted in Spanish. Our worship services are now bilingual - English and Spanish – and our attendees are from different nations, including, the United States, Mexico, Honduras, Nicaragua, Colombia, and Hungary!

My goal is to continue preaching the good news of salvation to "whosoever will", and to create a fellowship of believers in this area, where all are welcome, and can have a chance for a new beginning, like the one I had in North Miami in 1992. That year, I learned to trust, love, and obey God, and to love and to serve others as best I could. Indeed, Jesus died so we may love our neighbors as we are supposed to love ourselves.

I believe we all at Casa Loma can help turn our community around if we would just give God a chance to work in our lives. I know He can. Our services start at 11:00am with prayer, and sometimes followed by a time of fellowship, and nothing would make us happier than welcoming you sometime soon! Cordially,

#### FOR YOUR GOOD HEALTH

May is known as Better Sleep Month. The Better Sleep Council (BSC) aims to raise awareness about all of the benefits that come with better sleep and how lack of sleep can disrupt your everyday life. It is recommended that you

Sleep deficits are closely associated with weight gain, diabetes, high blood pressure, and a lower tolerance of chronic pain. When this issue because severe, poor sleep can be linked to serious sleep disorders such as restless leg syndrome, sleep apnea, insomnia, and narcolepsy.

Here are some great tips to help you get a betterquality night's sleep:

- Stick to a sleep schedule: go to bed and get up at the same time everyday
- Relax before sleeping: limit stimulating activities like exercise and work; do relaxing activities like reading or meditation
- Create a bedtime ritual: Doing the same thing every day gives your body a signal it's time to wind down

 Create an optimal sleeping area: The room should be cool, dark, and quiet. Get off of all electronic devices, consider using black out curtains, and soundproof earplugs as well



- Pay attention to what you eat/ drink: Don't go to bed hungry or stuffed
- Limit naps during the day: Long naps can interfere with nighttime sleep. Limit them to 10-30 mins
- Daily physical activity: This helps to promote falling asleep faster and has you get a deeper sleep

## THE HISTORY OF MEMORIAL DAY

Originally called Decoration Day, from the early tradition of decorating graves with flowers, wreaths and flags, Memorial Day is a day for remembrance of those who have died in service to our country. It was first widely observed on May 30,



1868 to commemorate the sacrifices of Civil War soldiers, by proclamation of Gen. John A. Logan of the Grand Army of the Republic, an organization of former Union sailors and soldiers.

During that first national commemoration, former Union Gen. and sitting Ohio Congressman James Garfield made a speech at Arlington National Cemetery, after which 5,000 participants helped to decorate the graves of the more than 20,000 Union and Confederate soldiers who were buried there.

This national event galvanized efforts to honor and remember fallen soldiers that began with local observances at burial grounds in several towns throughout the United States following the end of the Civil War, such as the May 1, 1865 gathering in Charleston, South Carolina organized by freed slaves to pay tribute and give proper burial to Union troops.

In 1873, New York was the first state to designate Memorial Day as a legal holiday. By the late 1800s, many more cities and communities observed Memorial Day, and several states had declared it a legal holiday.

After World War I, it became an occasion for honoring those who died in all of America's wars and was then more widely established as a national holiday throughout the United States.




