


## MESSAGE FROM YOUR VP

### **Warning: Do Not Drink Miracle Mineral Solution (MMS) or Similar Products**

It has been on the news for years. The FDA first started warning consumers about the product in 2010. Interest in it pops up thanks to the internet. Products are still promoted on social media but the FDA warns you not to drink sodium chlorite products such as Miracle Mineral Solution. These products can make you sick. The products come in various names and are mixed with numerous chemicals. Some you have to mix while others are already pre-mixed. Once the solution is mixed with an acid, the mixture becomes a powerful bleaching agent, chlorine dioxide. Both the sodium chlorite and the chlorine dioxide are active ingredients in industrial disinfectants. They are not meant to be consumed by humans. Distributors of these products have been making false and dangerous claims that the product can cure multiple medical conditions from cancer to Covid-19. The product can cause severe reactions and acute liver failure.

**Bottom line:** Sodium chlorite products are dangerous and you and your family should not use them.

### **Buyer Beware: Hand Sanitizers with Methanol**

The FDA has a warning for consumers that some hand sanitizers have tested positive for methanol contamination. Methanol is wood alcohol that can be toxic when absorbed through the skin or life threatening if ingested. Most of the products listed on the recall list are products “Made in Mexico”. For a list of recalled products go to [www.fda.gov](http://www.fda.gov) and click on FDA update on Hand Sanitizers. The CDC still recommends that washing your hands for at least 20 seconds with soap and water is the best way to prevent the spread of germs and viruses. If soap and water is not available, the CDC recommends the use of an ethyl alcohol based hand sanitizer that is at least 60% ethanol.



### **Can Hand Sanitizer be kept in a hot car?**

According to the National Fire Protection Association (NFPA), hand sanitizer would have to reach up to 700 degrees Fahrenheit for it to catch fire without the presence of a flame or spark. Even in the heat of summer, the inside of your vehicle would never reach temperatures that are going to be a concern. *There is a concern of heat and direct sunlight degrading some ingredients in hand sanitizer causing it to be less effective.* If you use it regularly and keep it in the shade, it is not an issue. It is best to store hand sanitizer in a cool, dry environment. If left in the car, it is best to leave it in the console were it is out of direct sunlight.






